**CONSIDERATION AND POSSIBLE APPROVAL OF  
REVISED 2020-21 SCHOOL CALENDAR**

**ISSUE**

In order for Staff to collaboratively plan and execute a strong Distance Learning model for the beginning of the 2020-21 school year, additional professional development, preparation, and planning time has been requested by the Forestville Teachers Association.

**INFORMATION**

Administration and Teaching staff have conferred and agree that moving the start of student instruction back to August 24, this will allow the additional professional development, preparation, and planning time necessary to provide a rich Distance Learning program. The District plans to use part of this time to provide professional development.

The proposed revised calendar starts student instruction on Monday, August 24, 2020. 180 days of student instruction, per year, is required by the State. The last day of school would be extended to June 10, 2021.
