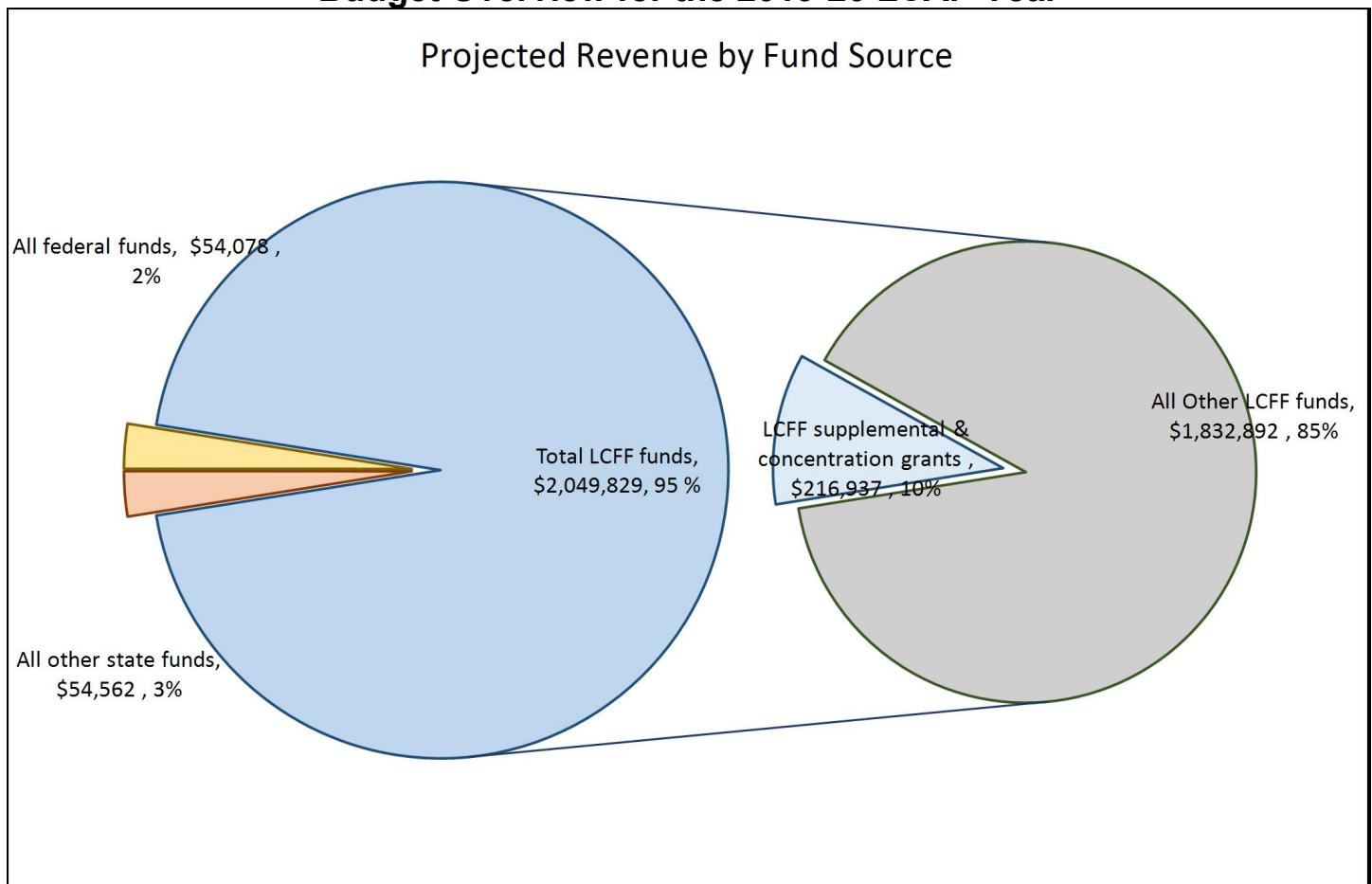

School districts receive funding from different sources: state funds under the Local Control Funding Formula (LCFF), other state funds, local funds, and federal funds. LCFF funds include a base level of funding for all LEAs and extra funding - called "supplemental and concentration" grants - to LEAs based on the enrollment of high needs students (foster youth, English learners, and low-income students).

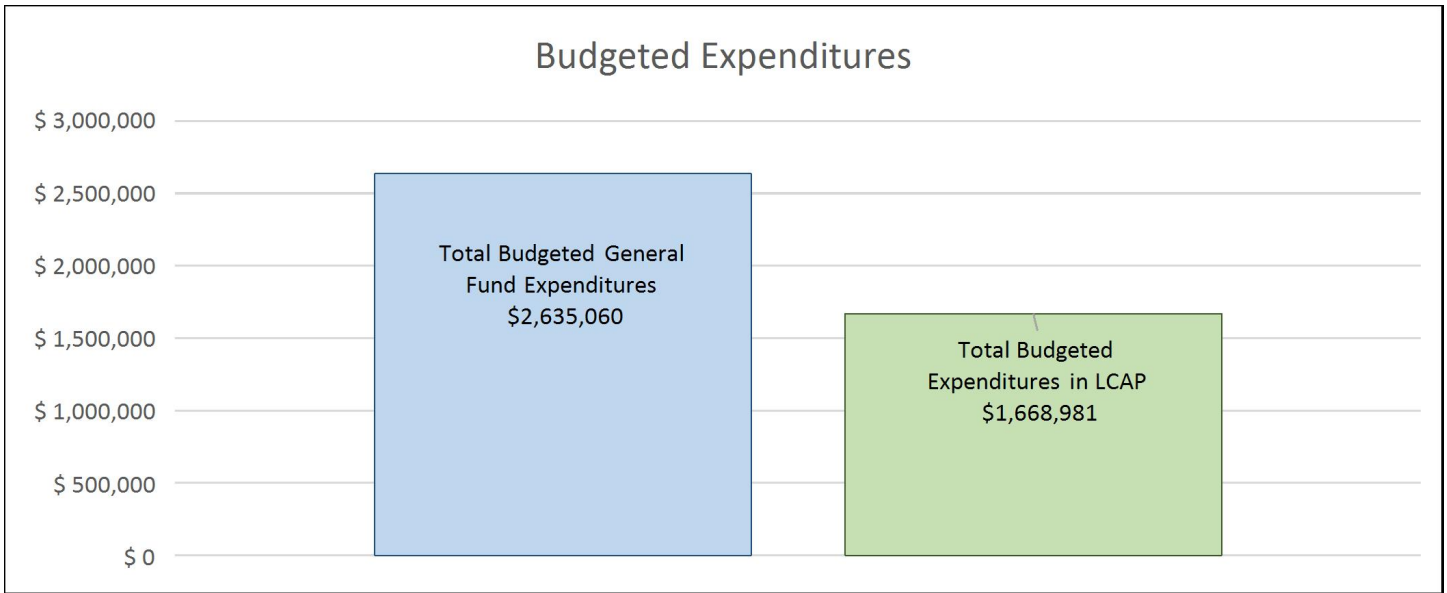


This chart shows the total general purpose revenue Forestville Union School District (Academy 2-8) expects to receive in the coming year from all sources.

The total revenue projected for Forestville Union School District (Academy 2-8) is \$2,158,469, of which \$2,049,829 is Local Control Funding Formula (LCFF), \$54,562 is other state funds, \$0 is local funds, and \$54,078 is federal funds. Of the \$2,049,829 in LCFF Funds, \$216,937 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

The LCFF gives school districts more flexibility in deciding how to use state funds. In exchange, school districts must work with parents, educators, students, and the community to develop a Local Control and Accountability Plan (LCAP) that shows how they will use these funds to serve students.



This chart provides a quick summary of how much Forestville Union School District (Academy 2-8) plans to spend for 2019-20. It shows how much of the total is tied to planned actions and services in the LCAP.

Forestville Union School District (Academy 2-8) plans to spend \$2,635,060 for the 2019-20 school year. Of that amount, \$1,668,981 is tied to actions/services in the LCAP and \$966,079 is not included in the LCAP. The budgeted expenditures that are not included in the LCAP will be used for the following:

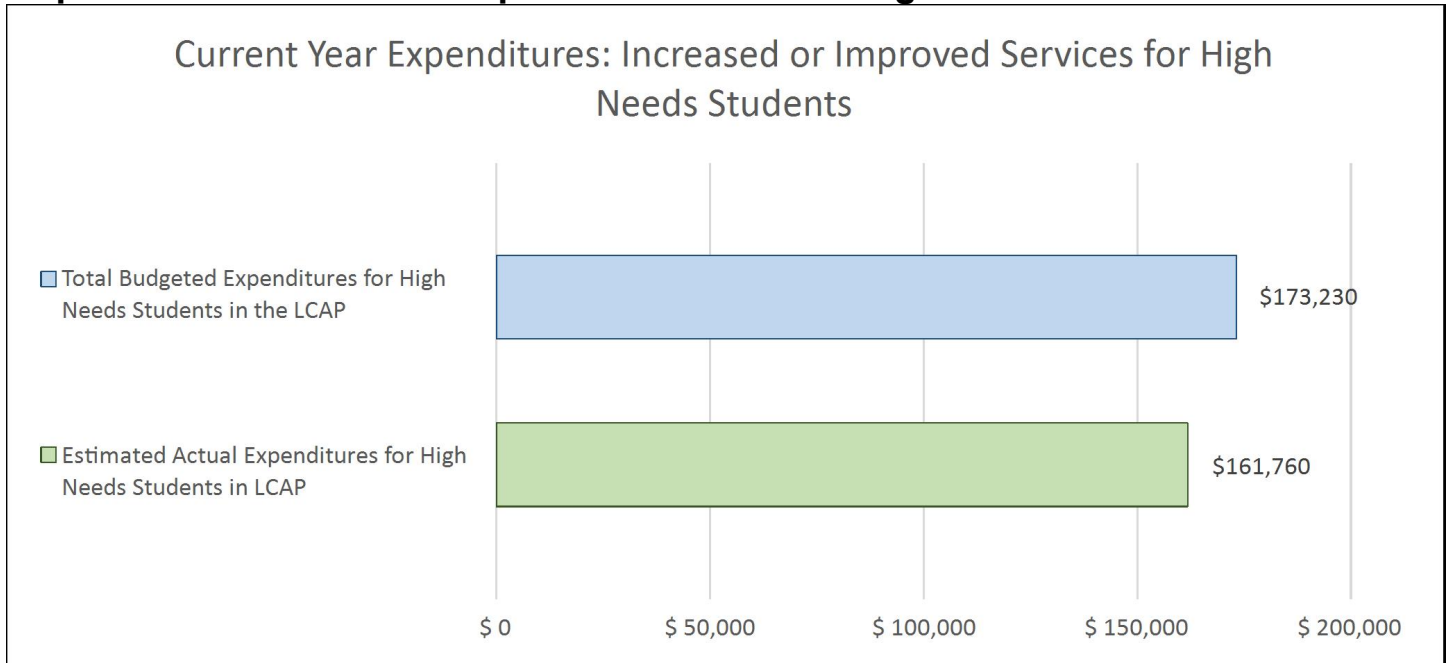

Increased or Improved Services for High Needs Students in 2019-20

In 2019-20, Forestville Union School District (Academy 2-8) is projecting it will receive \$216,937 based on the enrollment of foster youth, English learner, and low-income students. Forestville Union School District (Academy 2-8) must demonstrate the planned actions and services will increase or improve services for high needs students compared to the services all students receive in proportion to the increased funding it receives for high needs students. In the LCAP, Forestville Union School District (Academy 2-8) plans to spend \$219,513 on actions to meet this requirement.

Update on Increased or Improved Services for High Needs Students in 2018-19



This chart compares what Forestville Union School District (Academy 2-8) budgeted last year in the LCAP for actions and services that contribute to increasing or improving services for high needs students with what Forestville Union School District (Academy 2-8) estimates it has spent on actions and services that contribute to increasing or improving services for high needs students in the current year.

In 2018-19, Forestville Union School District (Academy 2-8)'s LCAP budgeted \$173,230 for planned actions to increase or improve services for high needs students. Forestville Union School District (Academy 2-8) estimates that it will actually spend \$161,760 for actions to increase or improve services for high needs students in 2018-19.

The difference between the budgeted and actual expenditures of \$-11,470 had the following impact on Forestville Union School District (Academy 2-8)'s ability to increase or improve services for high needs students:
